2017 年 2 月 15 日, 瑞欧科技正式迁址, 入驻未来科技城海创科技中心, 逐梦扬帆, 笃志远行, 开启合规服务新征程。

2017 年 3 月 24 日, 瑞欧科技成功举办首届"环境安全与健康发展高峰论坛", 聚焦环境 安全与健康发展两大主题, 通过跨领域的前沿政策分析为政府提供决策依据、为企业提供发 展方向、为品牌进入中国市场提供政策助力, 引发各界的热烈关注和讨论。

2017 年 3 月 17 日, 金砖国家标准化研究联盟成立会暨金砖国家标准化研讨会在杭召开, 瑞欧科技成为金砖国家标准化研究联盟首批成员, 与其他联盟成员共同研究金砖国家标准化 法律法规、标准战略、体制机制和标准系统等内容, 服务我国与其他金砖国家间的标准化合 作交流, 提高"中国标准"国际影响力, 促进我国与其他金砖国家经贸健康发展。

2017 年 11 月 2 日,第九届全球化学品法规年度峰会 CRAC2017 圆满落幕,来自化学品、 农药、消费品、食品接触材料四个行业的 300 余位官方代表、行业专家、企业代表和社会媒体共聚杭州,交流行业法规动态,共享合规要点经验,推动行业绿色、安全、可持续发展。

2017 年, 瑞欧科技互联网事业部应运而生, 进一步优化亚太区法规资讯平台 Chemlinked、 供应链管理软件瑞欧云 Cloud、在线会议系统 iMeeton 等软件和信息化产品。



2017 Highlights

On February 15, 2017, REACH24H officially relocated and settled in Haichuang Technology Centre with the ambition to open a new journey of compliance service.

On March 24, 2017, REACH24H successfully held the first "Forum on Environmental Safety and Health Development", focusing on the two major themes of environmental safety and health development. The forum focused on providing cutting-edge policy analysis across industries and decision-making basis for the government, development direction for the brand accessing to the Chinese market with policy support. The forum aroused the enthusiastic attention and discussion.

On March 17, 2017, the founding ceremony of the BRICS National Standardization Research Alliance and the BRICS Standardization Seminar were held in Hangzhou. REACH24H became the first batch member of the BRICS National Standardization Research Alliance. Together with other coalition members, REACH24H studied BRICS Standardization of laws and regulations, standard strategies, institutional mechanisms and standard systems, to serve for the standardization cooperation and communications between China and other BRICS countries, to enhance the international influence of the "China Standard" and to promote the healthy economic and trade development of China and other BRIC countries.

On November 2, 2017, the 9th Annual Chemical Regulation Conference – CRAC2017 concluded successfully. More than 300 officials, industry experts, business representatives and media from the four industries of chemicals, pesticides, consumer products and food contact materials gathered in Hangzhou, exchanged ideas of industry regulations updates and shared compliance experiences to promote the green, safe and sustainable development of the industry.

In 2017, REACH24H established the Internet Affairs Department to further optimize the AP region information platform Chemlinked, the supply chain management software SDS Cloud, the online conference system iMeeton and other information technology products .

It is also the first service organization in China to be granted a Lead Registrant (LR) status.

The REACH Regulatory Affairs Department has been studying and carrying out Korean REACH (K-REACH) compliance services since 2015. In just two years, relying on a wealth of compliance experience, REACH24H has achieved an excellent performance on its K-REACH compliance programs, serving as the leading registrant for several substances in the 510 existing registries as well as providing technical support to hundreds of jointly registered substances. New material registration and registration exemption applications show a year by year increase with an annual growth rate of about 90%.

中国新化学物质环境管理办法

☆ 2017 年 8 月,环保部发布关于调整《新化 学物质申报登记指南》数据要求的公告,公告 发布之初,瑞欧科技亚太区化学品登记部与固 管中心进行了多次的良好技术交流并反馈了众 多企业对于数据要求的建议,同时就《新化学 物质申报登记指南》其他内容的修订,与固 管中心分享了其他国家和地区的新化学物质 管理要求。

☆ 2017 年初,上海启动新化学物质登记自查 工作,亚太区化学品登记部积极协助多家上 海企业完成自查材料的准备以及现场审核工 作,同时,也将上海自查工作与多个地方环 保部门进行分享。《新化学物质环境管理办法》 修订在即,亚太区化学品登记部将继续保持 与官方的密切交流,分享反馈实际工作中遇 到的问题及企业建议。

目前瑞欧科技服务的企业及申报的项目呈稳 定增长趋势,截至2017年底,瑞欧科技已完 成近2000件新化学物质申报项目,涉及到各 个类型及吨位级别的申报服务。未来瑞欧科 技也将继续与官方保持良好的沟通,与国内 外实验室维持紧密的合作,通过专业的技术 能力和多年积累的合规经验助力国内外企业 跨越技术性贸易壁垒,抢占贸易市场。



Industrial Chemical Division Asia Pacific Chemical Registration Department

One-stop compliance services for AP region chemicals

The Asia Pacific Chemical Registration Department is committed to tracking China Measures on the Environmental Management of New Chemical Substances, Taiwan Toxic Chemical Substances Control Act and Occupational Safety and Health Act, Japan Chemical Substance Control Law and other chemical regulations in effect in Thailand, Philippines, Vietnam, Australia and other Asian Pacific countries. We are also providing CAS No. application services. Benefiting from a professional technical team and international support service, by the end of 2017, the Chemical Registration Department has successfully helped thousands of domestic and foreign enterprises register new chemical substances in China, manage existing chemical substances and new chemical substances registration in Taiwan, filings following Japan CSCL regulation, Thailand's Annex 5.6 material filings and other compliance work.

China's Measures on the Environmental Management of New Chemical Substances

Amendments to the data requirements contained in China's New Substance Notification Guidance were published on Aug 28th 2017 as an individual announcement. Soon, the REACH24H AP Chemical Registration Department began focusing on the task of building several technical communication platforms with SCC-MEP, and presenting companies' advice on the data revision. At the same time, we began to share our knowledge on new chemical control regulations in other countries and regions. ☆ In the early 2017, Shanghai launched an inspection program for new chemical substances registration. The AP Chemical Registration Department actively assisted a number of Shanghai enterprises in preparing all inspection materials as well as on-site audit work. Meanwhile, Shanghai shared its inspection experience with a number of local environmental protection departments. The revision of the Measures on the Environmental Management of New Chemical Substances is expected to be published soon, and the AP Chemical Registration Department will continue to maintain close communications with officials and share feedback on practical problems and business proposals.

For now, REACH24H has completed around 2000 new chemical substance notification projects, covering various types and tonnage threshold notification. More importantly, the number of service targetted and notification projects have achieved a stable increase. In the near future, REACH24H aims to continue to maintain a good and smooth communication channel with relevant authorities and close cooperation with labs globally. Our team will remain devoted to assisting foreign and domestic companies in overcoming technical barriers to international trade and seize the trade market through its technical expertise and years of accumulated compliance experience.

台湾毒性化学物质管理 (TCSCA/OSHA)

自台湾毒性化学物质管理(TCSCA/OSHA)法 规实施以来,瑞欧科技深入研究法规要求,积 极与主管机构沟通交流,2015年4月,台湾 化学物质登录中心受瑞欧科技邀请来杭为企业 介绍台湾化学物质登录管理办法,这是法规实 施后台湾地区主管官方首次在中国大陆分享台 湾化学物质登录信息。

2017年5月, 瑞欧科技在台北举办全球化学 品和材料合规实践研讨会, 会上瑞欧科技法规 技术咨询师和官方代表就台湾化学品管理工作 进行了详细的介绍。2017年9月, 瑞欧科技 举办"台湾化学物质登录进展及经验分享"网 络培训会, 邀请台湾化学物质登录中心与众多 企业分享了化学物质登录经验及最新资讯。随 着 2018年既有物质标准登录的临近, 瑞欧科 技积极与台湾多个主管部门保持紧密联系, 并 与其分享其他国家及地区的化学品管理要求, 广泛搜集行业内的建议和反馈, 为台湾既有物 质标准登录的实施提供了有力的支持。 截至 2017 年底,瑞欧科技亚太区化学品登记 部已协助全球众多企业完成了 5000 多项化学 物质登录工作,其中包括既有化学物质第一 阶段登录及新化学物质多种登录类型。在新 化学物质标准登录服务能力方面,无论是项 目的数量还是质量都得到了台湾地区主管机 构的高度认可。丰富的全球化学品合规经验, 与主管机构的紧密联系,与多家台湾地区测 试机构的良好合作等优势让瑞欧科技得以在 即将到来的既有化学物质标准登录工作中为 企业提供有力的技术保障。

截至 2017 年 12 月 31 日,在台湾官方公布的 62 件简易登录登记证中,其中 10 件为瑞欧提 交,占总数的 16%;而在技术难度更大的标 准登记中,瑞欧更是独占半壁江山,成功申 请了7 笔标准登录,占总数的 50%。瑞欧也 是第一家以及迄今为止唯一一家取得标准登 录二级的企业,显示了瑞欧在难度较大的高 吨位台湾化学物质登录中的雄厚实力。



Taiwan Toxic Chemical Substances Control Act and Occupational Safety and Health Act

Since the implementation of the Toxic Chemicals Management (TCSCA / OSHA) regulation in Taiwan, REACH24H has conducted in-depth research on regulatory requirements and it has maintained active communications with the competent authorities. In April 2015, the Taiwan Chemical Substance Registration Center was invited by REACH24H to introduce Taiwan's chemical substances registration management approach to companies, which represents the first time Taiwanese officials visit mainland China to share information on the registration of chemical substances following the implementation of these of laws and regulations in Taiwan.

In May 2017, REACH24H held a seminar on global compliance for chemicals and materials in Taipei. At the meeting, technical advisors and official representatives from REACH24H carried out a detailed introduction on the management of chemicals in Taiwan. Later in September 2017, REACH24H held a webinar on Progress and Experience Sharing in the Registration of Chemical Substances in Taiwan and invited the Taiwan Chemical Substance Registration Center to share its experience with a number of enterprises on the latest information on chemical substance registration. With the approach of the 2018 Existing Chemical Standard Registration, REACH24H actively maintains close contacts with various competent authorities in Taiwan and shares chemical management requirements of other countries and regions with them and collect suggestions and feedback from a number of related industries. In this way, the Division has been able to steadily support the release and implementation of the existing regulations on the standard registration of existing substances in Taiwan.



By the end of 2017, more than 5,000 chemical substances registrations have been completed by the REACH24H AP Chemical Registration Division, including the Phase I existing chemical substances registration (late pre-registration) and the registration of new chemical substances. In terms of new chemical substance standard registration service capabilities, both the number and quality of projects have been highly recognized by the competent authorities in Taiwan. The rich experience in global chemical compliance, close contacts with the competent authorities and good-standing cooperative relations with a number of testing organizations in Taiwan have enabled REACH24H to provide enterprises with the opportunity to complete existing chemical substances standard registration with strong technical support.

As of December 31, 2017, of the 62 simple registration certificates officially announced by Taiwan, 10 of them were submitted by REACH24H, accounting for 16% of the total. In the case of more technically challenging standard registrations, REACH24H successfully applied for 7 standard registration, accounting for 50% of the total. REACH24H is also the first and to date the only company that has achieved the Level 2 standard login registration, demonstrating its solid strength in more challenging high-tonnage chemical substances registration in Taiwan.

Provide global GHS compliance solutions

The GHS Compliance Affairs Division, established in 2014, is committed to providing global GHS compliance consulting services. Over the years, its professional technical expertise and rich experience in compliance have made it the first choice of hundreds of domestic and foreign enterprises, including Dow and BASF. In addition, this department established a good cooperative relationship with the State Administration of Work Safety, the Chemical Registration Center, the Ministry of Transport and other official agencies.

On February 16, 2011, the 144th executive meeting of the State Council formally adopted the revised "Regulations on the Safe Management of Hazardous Chemicals" which came into effect on December 1, 2011, marking China's formal implementation of the UN GHS. The technical team of the GHS Compliance Affairs Division has been tracking the evolution of China's GHS regulations since the establishment of the company and has further extended to global GHS compliance services. So far it has helped hundreds chemical enterprises prepare more than 30,000 SDSs and labels. In April 2015, the latest version of the inventory of Hazardous Chemicals was released and the new chapter in China hazardous chemicals management was made available. GHS Compliance Affairs Department invited officials to interpret the impact of the list on the industry as soon as it was released, and always maintained top activity. So far it has helped hundreds chemical enterprises finalize the registration of thousands of hazardous chemicals.

From 2016 to 2017, the GHS Compliance Affairs Department actively participated in the "Detailed Rules for the Implementation of Road Transport with Limited Quantity and Excepted Quantities of Dangerous Goods" compilation group led by the Secretary of Transport Services and the China Petroleum and Chemical Industry Federation. It also participated in multiple meetings with other representatives, and actively assisted the preparation of the new standards. The GHS Compliance Affairs Department is at the forefront of research on the regulations of the transport of Chinese dangerous goods and it is committed to providing enterprises with consulting services on all types of dangerous goods.

GHS Compliance Affairs Department will continue to provide professional technical services and promote chemical safety management to help enterprises trade successfully.

External Training and Teaching courses

The management of hazardous chemicals for compliance is a field that involves many details and specific data which can result confusing to chemical enterprises. Throughout 2017, REACH24H was invited to attend various industry conferences and delivered speeches on many occasions, including Sinopec Gas and Oilfield Hazardous Chemicals Management Training Program, Shanghai Petrochemical Federation Training Course, Ningbo Inspection and Quarantine Bureau Hazardous Materials Training Seminar, and Chemical Safety Management Training Course. At the same time, REACH24H has also remained active globally, successfully providing online and offline customized training services to many well-known enterprises at home and abroad.

☆ In April, the conference on the latest trends of chemical substance management policies sponsored by REACH24H was successfully concluded in Tokyo, Japan. The meeting detailed compliance requirements for hazardous chemicals following the implementation of the new catalog of hazardous chemicals, helping enterprises better understand the policies associated to the management of hazardous chemicals.

Chemical accidents and environmental pollution incidents caused by the lack of effective management have shown a high tendency. In order to effectively prevent serious accidents associated to hazardous chemicals, ensure the health and safety of people and properties, and protect and improve the quality of the environment, the government is actively improving and updating its laws and regulations on safety and environmental protection and gradually increasing penalties for illegal behavior and law violations. Carrying out chemical safety controls and fulfilling environmental management obligations has become an important component of chemical companies' sustainable development.

Based on the principle of "Value in Compliance", the EHS Regulatory Affairs Department of REACH24H expects to relieve enterprises from the heavy duty of analysing complex laws and regulations on environmental protection and safety regulatory standards. One-stop service on pesticides, disinfectants and food contact materials-related global laws and regulations

Founded in 2013, the Agrochem and Material Division adheres to the philosophy of value in compliance, always committed to providing quality domestic and foreign regulatory and technical advisory services to companies operating in the fields of pesticides, disinfectants and food contact materials. More than 60% of the team hold a Master's degree or above or have an overseas study background. The technical team's majors include toxicology, pharmaceutical chemistry, ecology, materials, food and pesticide, underscoring their professional technical ability and rich compliance experience.

Helping Chinese pesticide companies enter the European and American markets

The EU and US markets have long been a symbol of high thresholds and high profits for Chinese pesticide companies. In addition to the highquality requirements imposed on the pesticide and formulation products themselves, the stringent registration system, complex regulatory system and difficult compliance work have deterred many enterprises.

Since 2014, the Agrochem and Material Division has been studying pesticide regulations in Europe and the United States in depth. With its own research experience in European and American disinfectant regulations, it provides one-stop compliance services to Chinese pesticide companies, successfully assisting them to complete the EU Pharmacy Equivalence Assessment (TE assessment), the United States EPA pesticide registration, ensuring the high-level technical support demanded to access the European and American markets.

Helping China's food contact materials companies access the US market

Due to the product characteristics of food contact materials, US FDA is particularly strict on the management of new substances in such products. A Food Contact Notification (FCN) must be completed before the products are listed in the United States. Such stringent regulatory requirements shut out many Chinese Food contact materials companies from this market.

The Agrochem and Material Division spent two years and invested considerable research efforts to, as of 2015, provide regulatory compliance services for food contact materials sold in United States, in the European Union and in China. As of 2017, the Agrochem and Materials Division has successfully filed fluorescent whiteners, antibacterials and UV absorbers on behalf of China's enterprises, helping them strengthen their technical foundations and gain a spot in the global market.

In order to respond to the development needs of enterprises, solve commonly faced difficulties and promote the rapid growth of registered personnel, REACH24H holds a pesticide registration training course every year. 助力进口婴幼儿奶粉进军中国

2016年,国家食品药品监督管理局出 台《幼儿配方乳粉产品配方注册管理 办法》法规,要求国内外婴幼儿奶粉 在2018年1月1日之后需先行注册配 方才可上市。面对紧迫的截止日期、 复杂的申报卷宗和流程以及巨大的沟 通困难,诸多进口奶粉品牌对婴幼儿 配方奶粉注册头痛不已。

食品事业部抓住此市场契机,从16年 起密切追踪相关法规并多次与评审专 家交流。17年正式开放注册后,食品 部已协助多个品牌完成配方注册,扫 清了进口奶粉企业在中国市场最难逾 越的障碍。

联手海外政府和协会,驾进口食品直通车

One-stop service to remove import regulatory barriers

Established in 2013, the Food Department is committed to providing one-stop compliance services for China's imported food. With a group of professionals and international staff, we have served hundreds of domestic and overseas clients, including giants in the food industry like Fonterra and Lee Kum Kee. We have also developed cooperative relationships with the New Zealand and South Africa Embassy as well as other partners.

Facilitating the entry of imported infant formula into China

In 2016, the China Food and Drug Administration (CFDA) issued the Administrative Measures for the Registration of Infant and Young Children Milk Powder Formula Recipes, requiring that both domestic and overseas infant formulas be registered before entering the market on 1 January, 2018. This new regulation meant big headaches for numerous infant formula brand owners due to the short deadline, complicated application dossiers and procedures, and difficult communication.

Grasping this market opportunity, since 2016 our department has closely tracked relevant regulations and maintained regular communications with assessment experts. Since the implementation of the recipe registration system, we have assisted brands in completing the registration process, eliminating the biggest barrier standing in the way of the imported formula industry in China.

Offering direct access for imported food along foreign governments and associations

Due to the great number of food types and variations among different types of regulations, exporters usually seek help from each country's relevant authorities. We have developed close relationships with overseas governmental agencies and associations in the food industry. When new regulatory updates applicable to their important industries emerge, we help provide timely regulatory interpretation and consultation by means of reports, online webinars and offline trainings, all of which has earned us a great number of positive reviews and recommendations. We not only provided direct solutions to our clients, we also expanded REACH24H's image overseas, setting the stage wider exchanges and cooperation opportunities.

In 2017, having displayed an outstanding performance in the area of regulatory compliance, the Cosmetics Department was invited to attend significant international events and seminars as an honored guest, like STANPA, PCPC, ICMAD, CBE, In-cosmetics, CBBC, ACBC, TCMA, MATRADE, etc., delivering insightful speeches on regulatory updates and comprehensive training courses.

Continually Enhanced Technical Skills

In 2014, China FDA published a new regulation that establishes that cosmetic safety reports may be submitted in replacement of toxicological tests. This new policy encouraged a greater number of successful product launches without requiring animal testing.

However, safety reports require that safety assessors hold solid toxicology and product knowledge, as well as sufficient industry experience. Our technical team closely follows up on the latest global know-how supported by its strong technical capabilities. Ms. HE, the technical director, became a China Certified Toxicologist in Aug 2017. Therefore, currently joined by gualified and dedicated safety assessors, our technical team is more than ever committed to advancing the development of imported and exported cosmetics.

Your consumer products safety assessor

CPSD(Consumer Products Service Department), based on component material safety and compliance requirements, provides product material registration and notifications, product safety assessments, customized compliance consulting, standardization and process improvement services for automotive, textile, electronics, toys, etc.

Helping Chinese textile enterprises access the global market

The situation faced by domestic and international textile products at present is difficult at the least, with fierce competition and complicated laws and regulations. In addition to being regulated by domestic and international green laws and regulations (REACH regulation and the domestic "Environmental Protection Law"), the textile enterprises also get accredited requirements (such as Oeko-Tex Standard 100, GOTS, Bluesign, etc.), the internal rules of textile enterprises and consumer safety requirements are also growing as well, so far the domestic textile enterprises have (auxiliaries, fabric enterprises, clothing and garment enterprises, etc.) remained tired and passive amongst these changes.

In order to comply with requirements of the textile industry at home and abroad, since 2016 our department has developed an integrated system which incorporated relevant textile laws and regulations from the EU, United States, Japan and other developed countries. In addition, we have worked close together with a major textile industry association, the China Chamber of Commerce for Import and Export, to develop the ZFR Textile Regulation & RSL Searching Database (ZFR Database, in short). Since its release in March 2017, the ZFR Database has been officially approved by the Ministry of Commerce of China as well as the State Council. Author's articles published by ZFR Database have been reprinted by dozens of governmental agencies, testing websites and the media in China. With the rise of "BRICS" and the vigorous promotion of the "Belt and Road" (OBOR) initiative, ZFR Database has also integrated OBORrelated laws and regulations and added the "BRICs" module to allow textile enterprises to search through laws and regulations difficult to understand, gain a better understanding of unclear market access thresholds and untimely buyers' standard updates, among other issues. For textile enterprises, access to specific and detailed knowledge of the industry and emerging threats leads to success.

May 24, 2017: An overview of the national textile standards along the "Belt and Road" initiative released by ZFR Database was available on the WTO / FTA website.

September 5, 2017: The BRICS annual report on textile standards originally released by the ZFR Database was included in the official website of China's Ministry of Commerce Trade Remedy and Investigation Bureau.

September 25, 2017: CPSD was invited by the Ministry of Commerce to participate in the "Trade Barriers and US 337 Survey Response Training Course" and made a presentation on the introduction of ZFR Database.

REACH24H Cloud adopts a modular software, effectively installing a series of modules of the compliance registration data in various countries, the company's internal encryption registration data and SDS data

etc., allowing compliance information to be efficiently transmitted throughout the supply chain. The Cloud is also compatible with the company's internal SAP and other interface dockings, which enables enterprises and organizations to benefit from the one-stop method to exchange supply amounts and upgrade their safety compliance.

iMeeton One-stop digital conference system

Modern companies organize and co-ordinate conferences around the world every year through their different departments. REACH24H found that even for small and medium-size enterprises with a simple organizational structure, many iterations for gathering information, before and after, have taken place. At the same time quantitative information in meetings has been difficult to obtain in the traditional preparation process. Relying on REACH24H's experience in organizing meetings and internet technology, iMeeton, a one-stop digital conference system, was developed in 2017, which provides a cloud platform for enterprise-

Throughout 2017, each portal has extended with new content, such as a QA center that collects common questions in regulations, Market Insights which grants market information, ESEC which gives access to Chinese manufacturers to foreign buyers of pesticides.

☆为加强对危险化学品在使用环节的监管,明确 使用单位的登记义务,瑞欧科技受上海市相关主 管单位委托针对国内外化学品使用单位的登记开 展情况进行研究,对欧盟、美国、日本、澳大利 亚、越南、韩国、菲律宾、台湾等多个国家及地 区的使用单位化学品登记相关法律法规进行深入 的研究和探讨,借鉴国外先进管理经验,结合国 内实际情况提出一系列建议,推动上海市危险化 学品使用单位登记制度的完善。



More social responsibility and influence

Over the years, REACH24H has made great efforts in the field of chemicals regulations, always promoting the sustainable development of the chemical industry. Based on the indepth study of global chemical regulations and supported by its industry-leading technical strength, REACH24H assists governments in carrying out complex tasks, including analysis of laws and regulations, preparing research reviews and participating in government-led research projects, representing its mission statement of "Value in Compliance" and promoting the global chemical safety management system.

☆ In 2017, REACH24H was commissioned by the EU Commission to carry out an "assessment of the cumulative compliance costs in the chemical industry" in China and conduct a scientific assessment on the compliance status of the chemical industry in China, compliance costs and the implementation status of associated regulations.

☆ In light of the frequent accidents and the observed inability to provide the emergency recovery of dangerous goods in China in recent years, in order to learn from these mistakes and improve the recovery capability in China, as well as to fill the gaps in standardization in this field, the China National Standardization Administration launched the project preparing a series of national standards "Dangerous Goods Transport Emergency Rescue Guide" in June. REACH24H was invited to participate in this project supporting the research, formulation and drafting of the standards, and became a major contributor to the fourth part of this standard.

☆ In order to increase the level of supervision over the use of hazardous chemicals and clearly state the registration obligations of institutions handling chemicals, REACH24H was commissioned by relevant authorities in Shanghai to conduct a research on the registration of institutions using chemicals domestically and abroad. In addition, REACH24H studied and offered an in-depth discussion on the regulations existing in EU, US, Japan, Australia, Vietnam, South Korea, Philippines, Taiwan and other countries and regions related to the registration of chemicals using institutions, drawing upon advanced management experience abroad, and finally contrasted them with the reality in China. Recommendations were thus made to complete the Shanghai Registration System of Dangerous Chemicals by Using Institutions. ☆披荆斩棘,助力中国化工行业走向世界— 上海出入境检验检疫局与质检总局标法中心合 作在上海设立了WTO/TBT-SPS国家通报咨 询中心上海化学品研究评议基地,同时建立上 海技术性贸易措施公共服务平台,提升企业技 术性贸易措施应对能力,促进相关产品顺利进 入国际市场。瑞欧科技多次针对各国法规和标 准的修订、发布提出关键意见,为上级部门在 WTO/TBT-SPS通报和评议中提供了有力的技 术支撑,同时协助针对欧洲的化学品管理体系 开展法规梳理工作,为中国化学品安全管理体 系建设提供了重要的参考材料。

 ☆工业和信息化部于 2017 年初制定了《关于 推进实施 < 全球化学品统一分类和标签制度
> 的指导意见》(征求意见稿),瑞欧科技结 合多年实际服务经验,从实施进度、实施范围、 实施要求、实施计划几方面着手,提出了详实 的修改意见和参考依据。 ☆为了更好地实施《危险化学品目录》及《危 险化学品目录(2015版)实施指南》,国家 生产监督管理总局、国家安全生产监督管理总 局化学品登记中心组织编写了《危险化学品目 录使用手册》,基于瑞欧科技多年的化学品法 规服务经验和业界良好口碑以及前期对《实施 指南》的深入剖析,登记中心就《使用手册》 的内容向瑞欧科技征询反馈意见和建议,力求 内容上尽量完整和准确。

☆《新化学物质申报登记指南》是中国新化学 物质申报的重要技术支持文件,在指南文件修 订期间,瑞欧科技参考前期在新化学物质申报 工作过程中的实际经验以及对其它国家地区化 学品管理法规的深入研究,就指南文件中的修 订内容认真整理了诸多反馈意见,协助梳理其 他国家化学品法规的管理体系作为参考,积极 为中国新化学物质管理工作的进步出力,促进 中国化学品管理体系不断完善发展。



 \bigstar Help China's chemical industry step to the world ---- Shanghai SAIAC and Shanghai AQSIQ set up the Shanghai Research and Evaluation Base of WTO / TBT-SPS National Notification and the Shanghai Technical Trade Measures Inquiry Center to enhance the ability of enterprises to manage technical trade measures and promote the smooth entry of related products to the international market. REACH24H issued key opinions numerous times for many countries on the revision of laws and standards and provided a strong technical support to the superior departments for the WTO / TBT-SPS notification and comments. It likewise helped carry out the sorting of regulations of the EU chemicals management system and contributed important reference materials to China's chemical safety management system.

 \bigstar In order to strengthen the safety management system of the road transport of dangerous goods, the Ministry of Transport issued the Measures for Safety The Management of Road Transport of Dangerous Goods (Draft under review). During the formulation and review process, REACH24H and the United States Committee on the Transport of Dangerous Goods (COSTHA) jointly proposed the submission of detailed feedbacks and suggestions to the authority on the disputed and unclear parts regarding the actual needs of client companies. This proposal was officially affirmed and adopted by the authority. The draft opens the exemption of small package road transport of dangerous goods in China for the first time. In order to ensure that it can be effectively implemented and operated, the Transport Services Commission of the Ministry of Transport entrusted the China Petroleum and Chemical Industry Federation with the preparation of a "Guide to Limited Number and Exceptional Number Dangerous Goods Transportation on Roads ". REACH24H was invited to participate in the compilation of this guidebook.

☆ The Ministry of Industry and Information Technology prepared the Guiding on Promotion of the Implementation of the Globally Harmonized System of Classification and Labeling of Chemicals (Draft under review) early in 2017. Based on its many years of practical experience, REACH24H put forward detailed comments and references on the implementation status, scope, requirements and associated schedule.

☆ In order to better implement the "China Inventory of Hazardous Chemicals" and "Guidance for the Implementation of China's 2015 Inventory of Hazardous Chemicals (Trial period) ", the State Administration of Production and Chemical Industry Registration Center of the State Administration of Work Safety compiled a "User Manual for the Inventory of Hazardous Chemicals". Following REACH24H's wide experience in chemical regulatory services, its high reputation within the industry as well as its in-depth analysis of Guidance for the Implementation, the Registration Center consulted with REACH24H for feedbacks and suggestions on the contents of the User Guide to ensure its completion and accuracy.

☆ The New Chemical Substance Notification Guidance is an important technical support document for the notification of new chemical substances in China. During the review period, REACH24H, supported by its practical experience in the application of new chemical substances and in-depth study of chemical management of chemicals in other countries and regions, meticulously issued comments on the revised content of the Guidance, helping sort out the chemical management systems of other countries while contributing to the progress of China's new chemical substances management and promoting the continuous development of China's chemical products management system.

2017年11月2日, 第九届全球化学品法规年度峰会顺 利完成各项议程圆满闭幕,会议期间来自化学品、农药、 消费品、食品接触材料四个行业的 300 余位官方代表、 行业专家、企业代表和社会媒体共聚杭州、交流行业法 规动态,共享合规经验,共同推动行业绿色、安全、可 持续发展。

此次峰会分设了香精香料行业专场,化学品环境安全管 理分会场,全球农药登记管理分会场,消费品合规安全 分会场和食品接触材料分会场。香精香料专场重在解析 欧盟 REACH 法规在香精香料行业的实施状况和遇到的实 际问题。化学品环境安全管理分会场则梳理了全球多个 国家和地区的化学品管理以及法规监管趋势,为企业进 一步明确了法规重点和未来的合规管理方向。全球农药 登记管理分会场和食品接触材料分会场为参会的企业代 表同步更新了各个地区的最新法规要求。而在消费品合 规安全分会场着眼于全球不同地区消费品相关产品的法 规标准、供应链中禁限用物质的管控措施、绿色供应链 管理的合规大数据平台工具展示等内容。

Global Chemical Regulation Annual Conference

Since its launching in 2009, The Chemical Regulation Annual Conference (CRAC) has become a well-known annual event in the industry. From the sharing of updates on regulations to the sharing of compliance experience, CRAC has gradually developed into a comprehensive platform gathering government agencies, industry experts and enterprises both at domestic and international level. Apart from providing in-depth analysis of regulatory developments, industry trends, it has also become an important link for the exchange of ideas and communication in the fields of environmental protection, safety and health of various countries.

Unprecedented gathering for green development

On November 2, the 9th CRAC successfully concluded its 2017 agenda. Over 300 government officials, experts, business representatives and media from four industries including chemicals, pesticides, consumer products and food contact materials gathered in Hangzhou to exchange updates of industry regulations, shared compliance experience and jointly promoted the green, safe and sustainable development of the industry.

The conference included sessions focused on various topics: the Flavors and Fragrances Industry Special Session, the Chemical and Environmental Safety Management Session, the Global Pesticide Registration Management Session, the Consumer Products Compliance and Safety Session and the Food Contact Materials Session. The Flavors and Fragrances Session focused on the implementation of the EU REACH in the flavor and fragrance industry and offered an insight into the current situation and problems encountered by enterprises. The Chemicals Session reviewed regulatory updates and trends in various countries and regions around the world. It has helped enterprises further clarify the focus of regulations and the future direction of compliance management. The Pesticide Session and the Food Contact Materials Session consistently focused on the latest updates in terms of regulatory requirements in various regions for the participating enterprise representatives. Finally, the Consumer Products Session looked at the regulatory standards for consumer-related products in different regions of the world, regulatory controls on banned substances in the supply chain, and tools demonstrating compliant big data to achieve green supply chain management.

CRAC 2017 recieved distinguished guests from all fields, including experts from organizations responsible for overseeing the management and implementation of chemical regulations , such as Ms. Catherine Cornu from the European Chemicals Agency, Ms. LU Ling from SCC Ministry of Environmental Protection, Mr. CHEN Jinhe from the CRCC of SAWS, Ms. NI Yahui from the Taiwan EPA's Registration Center for Chemical Substances, Ms. CHEN Rongfang from Shanghai FDA, Ms. LIU Xia from China National Institute of Standardization etc., and also regulatory experts such as Takashi Fukushima and Shinobu Yoshida of the National Institute of Technology and Research (NITE) of Japan, Ms. Somsri Suwanjaras of the Thai Industrial Engineering Agency, Dr. Leonello Attias of the Italian National Institute of Health, Richard Davey of the National Chemical Emergency Center of the United Kingdom and Mr. Willi Weßelowscky from UMCO GmbH, Germany, among others.

At the conference, experts conveyed the spirit and purpose of various international legislations. Representatives of participating enterprises exchanged with experts questions in order to better understand regulations and assess difficulties in the compliance process, which led to improved and wider communication channels between the parties, as well as the standardization and transparency of compliance.

During the conference, REACH24H alongside its global partners Germany UMCO and the British National Chemical Emergency Response Center NCEC formally established the "Global Chemical Management Compliance Alliance" and issued the "Green Chemistry, Green Compliance and Sustainable Development" proposal, aimed at joining efforts to promote the benign management of chemicals in the life cycle and expand international cooperation in chemical management so as to jointly promote the green, safe and sustainable development of the chemicals industry.

瑞欧人

瑞欧的蓬勃发展离不开高素质的瑞欧人。瑞欧是一个年轻的公司,员工的平均年龄为28.4岁, 半数员工拥有国内外知名学府硕士及以上学历,专业覆盖化学、生物科技、环境、食品等。

"选、育、用、留",为瑞欧人才队 伍添砖加瓦

员工是瑞欧最宝贵的财富,优秀的人力资 源是公司发展的重要保障。人力资源部门 承担了"选、育、用、留"人才的重任, 负责公司的人力资源规划、招聘与配置、 培训与开发、绩效管理、薪酬福利管理和 员工关系管理的工作。

在 2017 年, 人力资源部在招聘方面也加强 了力度, 拓宽了人才引进的渠道, 如加强 校企合作、外地 / 外籍人才引进等。为公 司未来的业务发展做好充足的人才储备. 在 2017 年下半年,人力资源部将招聘重点 放在了 2018 年校园招聘上, 争取在 2018 年毕业生的优秀新生血液的招聘上抢夺先 机。在2017年下半年,人力资源部在杭州、 南京、武汉、西安及长沙五大城市的13所 名校(其中包括浙江大学、浙江工业大学、 东南大学、华中科技大学、西安交通大学 及湖南大学等)进行了校园宣讲会,并参 与了杭州市4所大学的招聘会, 共吸引了 400 多名学生,其中有 285 份简历通过了初 步的筛选, 共 98 人通过笔试并进入面试环 节。经过层层的选拔、共甄选出符合公司 要求的人才 38 人。在这一系列的招聘活动

中,人力资源部为公司发掘和识别人才,也努力 在高校及学生面前展示和营造瑞欧良好的雇主形 象和口碑,进一步推广了瑞欧的雇主品牌。

在 2017 年, 人力资源部门着重建立公司培训体 系并开展培训活动。全年共组织5次新员工入职 培训,帮助新员工了解瑞欧的品牌、业务、历史 和企业文化,使新员工更快地融入队伍。同时, 人力资源部也加强了专业培训,全年共组织12 期不同内容的培训,其中3场为专业培训,分别 是培训师培训、金牌电话销售技能培训和全公司 都参与的职业化素拓培训。另外、人力资源部首 次在公司内部组建了内训师队伍,为全体员工举 办了9门内部培训课程,共计216人次参加培训, 为历年来开展内部培训最多的一年。



REACH24H People

The vigorous development of REACH24H is inseparable from the REACH24Hers. REACH24H is a young company, the average age of employees is 28.4 years old, around half of the staff hold a master's degree or above from well-known domestic and foreign universities with majors in Chemistry, Biologic Technology, Environment, Food Science etc.

"Select, train, apply, retain": building talents for REACH24H

REACH24's most valuable asset is its staff, making human resources an important guarantee for the development of the company. The Human Resources Department undertakes the task of "selecting, training, applying and retaining" talent, and is responsible for the company's human resources planning, recruitment, training and development, performance appraisal, compensation benefits

and employee relationship management.

In 2017, our HR Department stepped up its efforts in recruiting and broadened the channels for talent acquisition, strengthening school-enterprise cooperation and introducing non-local/foreign talents. In the second half of 2017, the HR Department focused on campus recruitment for 2018. We are striving to take the lead in recruiting outstanding 2018 graduates. Campus recruiting talks were delivered to 13 famous universities (including Zhejiang University, Zhejiang University of Technology, Southeast University, Huazhong University of Science and Technology, Xi'an Jiaotong University and Hunan University) from Hangzhou, Nanjing, Wuhan, Xi'an and Changsha, also participating in the talent fairs of four universities in Hangzhou, which attracted over 400 students. A total of 285 young graduates passed the initial screening and 98 people passed the written test, thus accessing the interview stage. At the end of the selection process, a total of 38 people were identified as meeting the company's requirements. Through

these recruitment activities, the HR Department not only identified new talents for the company, also reinforced the company's good employer image and reputation to universities and students, further promoting the REACH24H brand.

In 2017, the HR Department has focused on establishing a clear training system and conducting training activities. Throughout the year, a total of 5 new employee induction trainings were held to help newcomers learn about the brand, business, history and culture of REACH24H, bringing new employees into the ranks more quickly. At the same time, HR Department also strengthened its professional training. A total of 12 training sessions were held throughout the year, of which 3 were professional trainings, namely Train The Trainer (TTT), trainings for gold medal call sales and professional quality trainings which were attended by the whole company. In addition, for the first time, the HR Department formed a team of in-house trainers to organize 9 internal training courses for all staff. A total of 216 people attended the training, making 2017 the year with most employees attending company trainings.

More technical experts, engineers are on the way

REACH24H attaches great importance to the enhancement of professional skills training and development of employees, and encourages them to obtain highly recognized certifications and qualifications. In 2017, three REACH24H employees obtained the toxicology certification, and one employee passed a re-certification as toxicologist. Toxicology certification has only a 30% pass rate, over which REACH24H maintains a 100% pass rate, demonstrating its excellent and solid technical strength in the technical field. The HR Department also actively carried out the work of declaring employees' professional qualifications. As of December 2017, a total of 56 employees have passed the Zhejiang Province and Hangzhou professional and technical qualification review stage, thus succeeding in obtaining their qualifications.
